Meeting Called to Order by TSGA President Paul Hill @ 10:30am

President Hill recognized the current TSGA Executive Committee- President Paul Hill (Karem), First Vice President Stuart Huffman (Alzafar), Second Vice President Sheldon Claborn (Suez), First Alternate Dugan Holt (Maskat), Second Alternate Jim Smith (Moslah), and Secretary / Treasurer Joey Powers (Khiva).

A reading of the financial report was given by President Hill. There was a suggestion to further review the TSGA Competition Rules and Regulations, Section 4, (h) to consider revising the trophy and awards due to the substantial cost involved. This review will be carried forward to the TSGA 2026 Midwinter meeting. Motion to accept the financial report (Davis) and second (Claborn) was made and passed.

President Hill gave some dates and information of future TSGA events:

TSGA 2026 Midwinter- Waco, Texas- Cottonwood- April 15-17- A packet was passed out to members present- Hill passed out a packet for the Midwinter meeting with itinerary and hotel information. Election of Officers was changed from a Friday to Thursday- Currently, Hella would be next followed by Khiva for nomination to 2nd alternate.

TSA 2026- Ben Hur is the host temple for TSA 2026. Hill said he was working with Star Ranch in Hutto for golf. Nothing definite at this time. Dates should be June 11-12.

TSGA 2027 Midwinter- Huffman said the meeting will be in San Antonio

TSGA 2028 Midwinter- Claborn is working on the details

Tournament Rules Committee- Chairman Davis presented a handout to all in attendance for the Rules of Play on the upcoming 2026 Midwinter. There was some discussion about the sand traps and putting. It was decided the conceded putts will be at 18" but will still count as a stroke. A measuring tool will be issued to each team or placed on each green prior to the beginning of each tournament day. Davis will send out the updated file after the meeting to be posted on the TSGA website.

Tournament Scoring Committee- Chairman Claborn reiterated on golfers writing down their actual score from each hole for each golfer. Powers asked that scores needed to correctly added by each team prior to turning in the scorecard.

Hospitality Chairman Martin said he and his committee were excited and looking forward to having one of the best hospitality rooms ever.

Swag bag Chairman Barben and co-chairman Steinocher have been working on securing items for the bags. Hill is expecting at least 72 golfers to attend.

Davis asked President Hill if the revised TSGA Rules and Regulations that were revised on 4/24/2025 had been signed. Hill presented a signed copy by Secretary Powers and President Beecher. Davis asked if they could be posted on the TSGA website.

President Hill asked if there was anything else for discussion. There being none, the meeting was adjourned.
